1. I am familiar with and accept on behalf of myself and my minor child/ward that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all disciplines in the performance of dance and acrobatics.
2. I have satisfied myself and believe that my minor child/ward is physically, emotionally and mentally able to participate in the classes and events taught, sponsored or participated in or on behalf of RNB.
3. I understand, and will instruct my minor child/ward, that regardless of his/her role, all applicable rules for participation must be followed and at all times the sole responsibility for personal safety remains with my minor child/ward; and
4. I will immediately remove my minor child/ward from participation in events, and notify the nearest teacher, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that my minor child/ward has experienced any deterioration in his/her physical, emotional or mental fitness.

I UNDERSTAND AND AGREE, ON BEHALF OF MY MINOR CHILD/WARD, HIS/HER HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, MYSELF, MY HEIRS, ASSIGNS PERSONAL REPRESENTATIVES AND NEXT OF KIND THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

1. AN UNQUALIFIED ASSUMPTION OF ALL RISKS associated with participation in the classes and events relative to the activities of RNB by my minor child/ward even if arising from negligence or gross negligence, including any compounding or aggravation of injuries caused by the operations of RNB, classes and instruction performed at RNB and/or events participated in by RNB and/or sponsored by RNB and of any persons associated therewith or participating therein; and
2. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have or may in the future have against any person (s), entities or organization (s) associated in any way with RNB Dance & Theatre Arts including lessees, promoters, sanctioning bodies or any subdivision thereof, operators, sponsors, advertisers, vehicle owners and other participants, rescue personnel, inspectors, underwriters, consultants, and others who give recommendations, directions or instructions, or engage in events or event premises or any one or more of them, and their respective directors, officers, employees, contractors, agents and representatives (all of whom are referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that my minor child/ward may suffer, or that his/her next of kin may suffer as a result of his/her use of, or presence at RNB's facilities, and sponsored or participation at events, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES; and
3. AN AGREEMENT NOT TO SUE THE RELEASEES for any loss, injury, cost of damages of any form or type, howsoever caused or arising, and whether directly or indirectly from the participation of my minor child/ward in any aspect associated with RNB or events or participation in and by RNB, both at its facility and at other locations; and
4. PART SIX **POLICIES**

DISCOUNTS:

- **EARLY BIRD DISCOUNT:**
2% Discount if fees paid in full upon registration; providing that registration is no later than October 15.

PAYMENTS FOR GENERAL FEES:

General program payments are annual fees; which are due on the 15th day of each month.

Payments can be made through automatic credit card payments (Visa, MasterCard) or by post-dated cheques.

Post-dated payment arrangements must be made at time of Registration.

There will be an automatic late penalty if fees are not received by the 15th day of the month that they are due - \$10.00 per month for fees less than \$100 and \$20.00 per month for fees more than \$100.

NSF fee of \$35 will be charged for returned payments.

ADDITIONAL CHARGES:

- **REGISTRATION FEE:**
A non-refundable registration fee of \$40 per student and \$20 for each additional family member (Adults or children) is due and payable upon registration.

ADDITIONAL CHARGES:

Festival, Exams and Costume Service Fees will be extra to the general lesson fees.

- **COSTUME SERVICE FEE:**
RNB Dance charges a costume service fee for the use of RNB costumes. A costume deposit of \$15.00 per class per performance will be charged at registration. Costume fees do not apply to Pointe, Technique or Stretch & Strength classes or similar classes that do not appear in the February or June Shows. Festival Costume fees will be included with Festival Costs.

OTHER INFORMATION:

- **WITHDRAWAL POLICY FOR GENERAL CLASSES:**
Mandatory one month's cancellation notice for general classes must be submitted IN WRITING to the Office Administrator. If this notice is NOT received, RNB will continue to charge for dance class (es). No refunds will be given without one month's cancellation notice. ***Lesson fees will not be refunded after March 31st.***
Registration fees, Exam fees, Competition/festival fees and Costume fees are non-refundable.

Withdrawal due to injury must be accompanied by a Doctors letter stating the student can no longer attend dance due to medical reasons (stated in letter).
- **WITHDRAWAL POLICY FOR EXAMS AND/OR FESTIVALS:**
No refunds will be issued for exams and/or festival fees.
- **ATTENDANCE:**
Attendance is compulsory. Should a student need to be absent, for a legitimate reason; he/she will be required to obtain prior approval from their teacher. Should a student be absent for medical reasons, the office must be notified IN WRITING.
- **VOLUNTEER POLICY:**
- Please view the duties available at RNB or online on our website. Each family is to choose where they would like to donate their **compulsory** volunteer hours. ***We would like you to commit to your volunteer activity at time of registration.***
- Volunteer commitment, for each family, will be from 5 to 10 hours per school year.
- A post-dated cheque or credit card authorization of \$50 dated June 1st, must be provided at registration.
- The payment will be returned if your volunteer commitment is met.
If your volunteer commitment is not met, you will be charged \$10 for each unfulfilled volunteer hour.
Senior students can earn accredited high school hours through this volunteer activity. Senior students may also undertake the volunteer commitment on behalf of the family; providing that they are capable of undertaking the assigned task.
